### **Personal Data Processing**

We will inform you about the services of CTT that you have requested. Your email address will be used for this purpose if you have given us prior permission to do so. In principle your personal data will be used by CTT only. We do not disclose personal

data to third parties without your permission, unless obliged to do so by law or court ruling.

We will never collect sensitive information about you without your explicit consent. The information we hold will be accurate and up to date. You can check the information that we hold about you by emailing us at [support@celestialtt.com](mailto:support@celestialtt.com). If you find any inaccuracies, we will delete or correct it promptly.

The personal information which we hold will be held securely in accordance with our internal security policy and the law. We do not hold information about you for longer than is necessary for the ends to which they were initially submitted and processed.

### Cookies

Cookies are small files of information, which often include a unique identification number or value, which are stored on your computer's hard drive as a result of you using the CTT software and accessing the CTT's website. We use both session ID cookies and persistent cookies. A session ID cookie expires when you close your browser. Session ID cookies are used in order to allow you to access your account online.

Persistent cookies remain on your hard drive for an extended period of time. Persistent cookies are used only to collect statistical information referred to above. Most internet browsers are set up to accept cookies.
